

ORDINANCE NO. 230-15

AN ORDINANCE OF THE CITY OF HACKBERRY, TEXAS, AMENDING ORDINANCE NO. 127-04, SECTION III. ADOPTION OF SPEED LIMITS; ESTABLISHING A SCHOOL ZONE ON KING ROAD; PROVIDING FOR SEVERABILITY, SAVINGS, AND EFFECTIVE DATE.

WHEREAS, the City Council of the City of Hackberry, Texas, deems it necessary to adopt and/or designate maximum speed limits with respect to vehicular travel on streets, roads and right-of-ways within the corporate limits of the City; and

WHEREAS, the growth of the City of Hackberry has created the need to add King Road to the list of streets and roads provided for in Ordinance No. 127-04; and

WHEREAS, the addition of a school within the corporate limits creates a need to establish a school zone on King Road to provide safety for children attending the school located at 303 King Road, Hackberry, Texas.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HACKBERRY, DENTON COUNTY, TEXAS:

ARTICLE I. AMENDING SECTION III. ADOPTION OF SPEED LIMITS AND ESTABLISHING A SCHOOL ZONE ON KING ROAD

A. Ordinance Number 127-04, Section III, Adoption of Speed Limits is hereby amended to read:

The following prima facie speed limits hereafter indicated for vehicles are hereby determined and declared to be reasonable and safe; and such speed limits are hereby fixed at the rate of speed indicated for vehicles traveling upon the named streets, roads, highways, right-of-ways, or parts thereof, described as follows in miles per hour (mph):

That from and after the date of passage of this speed zone ordinance and proper posting of required signs, no vehicle may be operated along and upon those portions of the streets, roads and/or right-of-ways described in this section of this Ordinance (230-15, Article I, Section A) within the corporate limits of the City of Hackberry, Texas in excess of the speeds set forth in Article I, Section A for those described portions, streets, roads, and/or right-of-ways.

B. Establishment of a School Zone and Speed Limit:

A school zone is hereby established from property line to property line of 303 King Road. The speed limit for vehicles traveling the street within the Holy Cross Catholic School during the hours of 7:45 a.m. to 8:30 a.m. and 3:00 p.m. and 3:45 p.m., school days, shall be 20 miles per hour maximum.

ARTICLE II. SEVERABILITY

Should any section, subsection, sentence, clause or phrase of this Ordinance be declared unconstitutional or invalid by a court of competent jurisdiction, it is expressly provided that any and all remaining portions of this Ordinance shall remain in full force and effect. The City hereby declares that it would have passed this Ordinance, and each section, subsection, clause or phrase thereof irrespective of the fact that any one or more sections, subsections, sentences, clause and phrase be declared unconstitutional or invalid.

ARTICLE III. SAVINGS


This Ordinance shall be cumulative of all other ordinances of the city and shall not repeal any of the provisions of those ordinances except in those instances where the provisions of, and only to the extent, those ordinances are in direct conflict with the provisions of this Ordinance. If any provision of this Ordinance conflicts with Chapter 342 of the Texas Health and Safety Code, then Chapter 342 shall control.

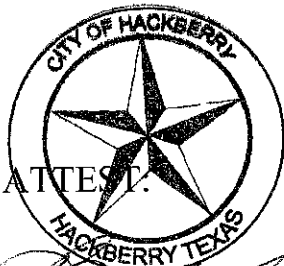
ARTICLE IV. EFFECTIVE DATE
