**1. Call to Order Special Session.**

**2. Public Comments:**

A person may address the Council on items not on the printed agenda. Comments are limited to three (3) minutes. The Council may not comment or deliberate regarding such statements or comment during this period. Any discussion of the subject must be limited to a proposal to place the subject on the agenda for a future meeting.

**3. Consent Agenda:** All matters listed under the Consent Agenda are considered to be routine by the Hackberry Council and require little or no deliberation. There will not be a separate discussion of these items and the agenda will be enacted by one vote. If the Council expresses a desire to discuss a matter listed, that item will be removed from the consent agenda and considered separately.

**4. Consider and take appropriate action on Change Order No. 1, Hackberry 200,000 gal Southside Elevated Water Storage Tank, Contractor Maquire Iron, Inc. for an additional \$49,800.00 – Paving.**

**5. Consider and take appropriate action on approving a Preliminary and/or Final Plat and Utility and Drainage Plans for Bridge Creek Shores Addition (13 Lots, 3 Tracts, 9.22 Acres) located within the city of Hackberry ETJ, Sycamore Drive west of Rivendale Pointe.**
