1. Call to Order Regular Session.

2. Public Comments:

A person may address the Council on items not on the printed agenda. Comments are limited to three (3) minutes. The Council may not comment or deliberate regarding such statements or comment during this period. Any discussion of the subject must be limited to a proposal to place the subject on the agenda for a future meeting.

3. Consent Agenda: All matters listed under the Consent Agenda are considered to be routine by the Hackberry Council and require little or no deliberation. There will not be a separate discussion of these items and the agenda will be enacted by one vote. If the Council expresses a desire to discuss a matter listed, that item will be removed from the consent agenda and considered separately.

6. Discuss and take appropriate action to approve the submittal of a preliminary application for Safe Routes to Schools (SRTS) and Transportation Alternatives (TA) funding to the Texas Department of Transportation.

7. Consider and take appropriate action on Ordinance No. 268-19, Amending the 2017/2018 Budgets.
