- 2. Public Comments:** A person may address the Council on items not on the printed agenda. Comments are limited to three (3) minutes. The Council may not comment or deliberate regarding such statements or comments during this period. Any discussion of the subject must be limited to a proposal to place the subject on the agenda for a future meeting. People wishing to speak on any posted agenda item may do so at this time or when the individual item is opened for consideration by the Council. Speakers will be limited to three (3) minutes unless a longer period is allowed by law for use of a translator. People wishing to speak must complete a speaker card identifying the agenda item that they wish to speak about and provide that card to the City Administrator so that they may be recognized by the mayor at the appropriate time.

The Amendment is for a Reassessment as required by Section 372.020 of the Act in order to reduce the amount of the annual Assessments due to a reduction in the Actual Costs of the Authorized Improvements.**
 6. Consider and take appropriate action on **Ordinance No. 369-26 approving an Amendment to the Service and Assessment Plan and Assessments Roll to be levied against the assessable property within the Rivendale Pointe Public Improvement District (the "District") pursuant to the provisions of Chapter 372 of the Texas Local Government Code, as amended (the "Act").
